Important deadlines:

- You must register to vote by **October 11.**
- You must submit your request to vote by absentee ballot by October 21.
- For the general elections, you can vote **October 30 November 1** from 8:00 a.m. to 6:00 p.m. or **November 2** from 8:00 a.m. to 2:00 p.m.

MAKE YOUR VOTE COUNT!

Step 1: Are you eligible to vote? Generally, you are eligible if you are:

- √ At least 18 (by Election Day)
- √ A citizen of the United States
- √ A resident of Oklahoma
- √ Are not currently on probation or parole for a felony conviction

If you have been convicted (found guilty) of a felony, you may not vote until you have completed any prison time and are no longer on probation or parole. Then, you may re-register and vote.



Step 2: Are you registered with current information?

You MUST be registered to vote! Check to see if you are registered and if your information is up-to-date at:



STEP 1: REGISTER TO VOTE

REGISTER ONLINE:

Register online using the OK Voter Portal's online voter registration system: https://okvoterportal.okelections.us/Home/RegWizard. An Oklahoma driver license/state ID and a signature on file with Service Oklahoma is required.

REGISTER BY MAIL:

Download a voter registration application (https://oklahoma.gov/content/dam/ok/en/elections/forms/voter-registration.pdf) from the State Election Board website or fill out a voter registration application (https://okvoterportal.okelections.us/Home/RegWizard) using the OK Voter Portal "wizard." Applications are also available at your County Election Board, most tag agencies, libraries, and post offices. Applications must be mailed or hand delivered to your County Election Board (https://oklahoma.gov/elections/about-us/county-election-boards.html) to complete the process.

REGISTER IN-PERSON:

Register at your County Election Board (httml) office, your local tag agency, or with select public assistance agencies when you apply for, update, or renew services. Submitted applications will be mailed to the State Election Board by the agency at no cost.

STEP 2: GO VOTE

VOTER ID REQUIREMENTS:

Proof of identification is required to vote in Oklahoma. There are three different ways to show proof of identity:

- **1. Photo Identification:** A document used for proof of identity for voting must have been issued by the United States government, the State of Oklahoma, or a federally recognized Tribal government and must contain the following information:
 - The name of the person to whom it was issued
 - A photograph of the person to whom it was issued
 - An expiration date that is after the date of the election, unless the identification is valid indefinitely

*The law requires the voter's name on the proof of identity document to "substantially conform" to the voter's name in the Precinct Registry. In other words, your name on your proof of identity must match your name in the Precinct Registry.

2. County election board voter identification card: Voters may use the free voter identification card they received by mail from the County Election Board when they registered to vote. The law allows use of the voter identification card even though it does not include a photograph.

3. Affidavit with provisional ballot: If you do not show proof of identity, you may vote only by provisional ballot. Voters who cast provisional ballots are required to fill out and sign an affidavit that explains why their provisional ballot should be counted. After Election Day, County Election Board officials will investigate the information provided by the voter on the affidavit and either will approve the provisional ballot for counting or will reject it based on the outcome of that investigation.

RETURNING BALLOTS FOR OTHERS:

You may not return ballots for others. Under Oklahoma law, it is almost always a crime to return someone else's absentee ballot on their behalf. You may do so only if you are the voter's spouse returning his or her ballot by mail, or if you are acting as an official and approved agent of an incapacitated voter.
