OREGON GENERAL ELECTION

Tuesday, November 5, 2024

Winners serve as our elected officials.




Oregon is an all-vote-by-mail state. Voters' pamphlets and ballots are automatically mailed to active registered voters two to three weeks before each statewide election. Voters can return ballots by mail or at any official drop box across the state.

Important deadlines:

- You must be registered by **October 15**. Registration cards postmarked by October 15 or submitted online by 11:59 p.m. on October 15 will be accepted.
- You must return your ballot by **November 5**. Mailed ballots must be postmarked by November 5. Ballots returned to an official drop box must be received by 8:00 p.m. on November 5.

STEP 1: REGISTER TO VOTE

REGISTER ONLINE:

You must have a valid Oregon driver's license (even if suspended), non-driver's photo ID, or Oregon driver's permit to register online: <u>https://bit.ly/46lLvrm</u>.

If you do not have an Oregon driver's license, permit, or ID card, you can still use the online voter registration application. The information you enter will display on a voter registration card (PDF document) that you will need to print, sign, and deliver to your County Elections Office to complete your registration by mail or in person.

REGISTER BY MAIL:

Print and complete the voter registration form: <u>https://sos.oregon.gov/elections/Documents/SEL500.pdf</u>. Then, mail it to your County Clerk's office: <u>https://sos.oregon.gov/elections/Pages/countyofficials.aspx</u>.

REGISTER IN PERSON:

You can register in person at your County Election Office (<u>https://sos.oregon.gov/elections/Pages/countyofficials.aspx</u>) or at certain agencies like the Department of Motor Vehicles.

STEP 2: GO VOTE

Oregon is an all vote-by-mail state. Voters' pamphlets with information on ballot measures and candidates are sent to Oregon residents two to three weeks before each statewide election, giving voters time to research issues on the ballot, including state and local measures and candidates.

Active registered voters receive an official ballot to complete and return. The ballot can be mailed back or dropped off at any official drop box across the state. Ballots must be received or mailed with a valid postmark by 8:00 p.m. on Election Day.

WHAT IF I DO NOT HAVE A PERMANENT RESIDENCE OR MY PERMANENT RESIDENCE DOESN'T HAVE AN ADDRESS ASSOCIATED WITH IT?

You have the same right to vote as anyone else—you just might need a little extra advice.

- Your permanent address need not be a place you go to every day. It's anywhere you stay at regularly and consider your home. That can be a family member's house, a friend's place, or a shelter. It can even be a park bench or other spot where you frequently return, although it will be easier if you can provide an address where you regularly receive mail.
- If you have a permanent residence but it does not have a standard address, you may be able to use a rural route number or description of your residence.
- If you lack a standard address and are unable to meet Oregon's proof of residence requirements, please contact us at <u>vote@narf.org</u>. We are here to help, free of charge.
